Introduction

This document outlines the NYSE Group Equity Volume Tier reports which contains month to date information on a T+1 basis on how a firm is tracking to individual tier programs and the relevant tiered rates and base rates as per current NYSE Equities fee schedules. This report is available daily for NYSE, NYSE Arca Equities, NYSE National, and NYSE American .

Naming Conventions and Formatting

1. Output file will be made available for secure pick-up via Managed File Transfer (MFT).
2. Output file will conform to the following standards:
 - a. File will be comma delimited.
 - b. File will not be sorted.
 - c. Headers will be provided.
 - d. File will be compressed and delivered as .dat.gz
 - e. File naming convention will support standard versioning controls.
3. Output files will be provided by CRD# only and follow standard naming convention:
 - a. <Market>_<Output Name>_<Type>_<FilterType>_<MFTID>_YYYYMMDD_Vx.dat.gz
 - i. ARCX: ARCX_CUST_TIER_EF_<CRD#>_<MFTID>_YYYYMMDD_Vx.dat.gz
 - ii. XNYS: XNYS_CUST_TIER_EF_<CRD#>_<MFTID>_YYYYMMDD_Vx.dat.gz
 - iii. XCIS: XCIS_CUST_TIER_EF_<CRD#>_<MFTID>_YYYYMMDD_Vx.dat.gz
 - iv. XASE: XASE_CUST_TIER_EF_<CRD#>_<MFTID>_YYYYMMDD_Vx.dat.gz
4. Output file will be made available at start day on T+1 after 7 a.m.
5. File will be a month to date file with cumulative activity that resets on the first of the billing month.
6. As new enhancements are made to these outputs, customers may expect to receive both current and new versions in their MFT file folder. All new versions will be tagged with a version number which will then allow the customer to migrate to the new file format when ready. Advance notification of dates will be provided with a minimum of 30 day notice dependent upon size and scope of changes.
