## 1. INTRODUCTION

---

An instance of the Volume Summary file is produced at the end of every trading day for the NYSE Group .

The file includes summary trading information for each security traded on the exchange during that trading day, regardless of listing market.

New Volume Summary files are available at the approximate times below. Historical Volume Summary files are available in the date ranges shown. All times are in US Eastern time.
